

 - Remove all devices in the 32U position and above.
 - Ensure that the heaviest devices are installed in the bottom of the rack cabinet.
 - Ensure that there are no empty U-levels between devices installed in the rack cabinet below the 32U level.
- If the rack cabinet you are relocating is part of a suite of rack cabinets, detach the rack cabinet from the suite.
- Inspect the route that you plan to take to eliminate potential hazards.
- Verify that the route that you choose can support the weight of the loaded rack cabinet. Refer to the documentation that comes with your rack cabinet for the weight of a loaded rack cabinet.
- Verify that all door openings are at least 760 x 230 mm (30 x 80 in.).
- Ensure that all devices, shelves, drawers, doors, and cables are secure.
- Ensure that the four leveling pads are raised to their highest position.
- Ensure that there is no stabilizer bracket installed on the rack cabinet during movement.
- Do not use a ramp inclined at more than 10 degrees.
- When the rack cabinet is in the new location, complete the following steps:
 - Lower the four leveling pads.
 - Install stabilizer brackets on the rack cabinet.
 - If you removed any devices from the rack cabinet, repopulate the rack cabinet from the lowest position to the highest position.
- If a long-distance relocation is required, restore the rack cabinet to the configuration of the rack cabinet as you received it. Pack the rack cabinet in the original packaging material, or equivalent. Also lower the leveling pads to raise the casters off of the pallet and bolt the rack cabinet to the pallet.



The intrabuilding ports of this equipment are suitable for connection to intrabuilding or unexposed wiring or cabling only. Overview of 58/88 or ED/R1 PCIe storage enclosure service

Find information to help you service the 58/88 or ED/R1 PCIe storage enclosure.



The Ultra SSD Drawer (feature code 58/88 and ED/R1) is a 1.8-inch solid-state drive (SSD) optimized PCIe storage enclosure that is mounted in a 19-inch rack. It attaches to supported POWER7[®] processor-based systems by using PCI Express generation 2 (PCIe2) GX++ adapters and PCIe2 cables. The 58/88 or ED/R1 PCIe storage enclosure includes the following components:

- Redundant power supplies
- Redundant fans
- Two redundant, large cache PCIe2 serial-attached SCSI (SAS) redundant array of independent disks (RAID) controllers along with redundant SAS port expanders
- Up to 30 1.8-inch dual port SAS SSDs

The 58/88 and ED/R1 PCIe storage enclosures contain two redundant enclosure RAID modules (ERMs), which contain a SAS RAID controller, a SAS port expander, and a replaceable fan assembly. Two power supplies provide an N+1 redundant feature that allows one power supply to power the entire enclosure if the other power supply failed or is missing.

- The two power supplies have built-in fans.
- Fan speed is automatically adjusted, as needed, to ensure correct cooling temperatures of the enclosure even when a fan fails.

The SAS RAID controllers are always configured in a dual controller (dual storage I/O adapter) configuration. This configuration provides redundant access paths to the SAS devices and mirrored copies of cache data and parity update footprints. The dual controller configuration also allows for increased performance capability when multiple RAID arrays are used in an Active/Active configuration mode. The SAS RAID controllers support RAID 0, 10, 5, and 6 and the hot-spare function.

The 58/88 or ED/R1 PCIe storage enclosure is a one EIA unit drawer that is mounted in a 19-inch rack. It is designed for light path service with light-emitting diode (LED) indicators on the front and rear of the enclosure chassis. These chassis LED indicators provide status and fault information for the following components and conditions:

- Enclosure identification
- Enclosure power
- Enclosure fans
- ERMs
- Enclosure faults
- SSD activity and SSD fault or identification

The PCIe storage enclosure is designed for front and rear service, performed in place (that is not in a service position) except for the midplane field replaceable unit (FRU) replacement.

PCIe storage enclosure infrastructure

Learn how the 58/88 or ED/R1 PCIe storage enclosure is different from previous storage enclosures.

With previous IBM® SAS storage enclosure models, connecting disk drives was accomplished by using individual components that were externally connected to each other:

- Storage enclosures
- Disk drive controllers
- SAS cables for multiple paths to devices and dedicated adapter-to-adapter connections




Figure 1. Dual storage IOA solution by using externally connected components

Figure 1 shows an example of a dual storage I/O adapter (IOA) solution by using externally connected components.




Figure 2. Dual storage IOA solution integrated within the 58/88 or ED/R1 PCIe storage enclosure

The following components and functions are integrated within the 58/88 or ED/R1 PCIe storage enclosure:

- The enclosure RAID module (ERM) contains the RAID adapter function and the expander function.
- The storage enclosure uses internal wiring to connect components with multiple redundant paths, eliminating the need for external SAS cables.
- A maximum of 30 1.5-inch solid-state drives (SSDs) may be installed in the storage enclosure.




Figure 3. One 58/88 PCIe storage enclosure connected to a single 02E/4C or 05E/6C system by using one FC EJ03 PCIe2 GX++ adapter and two PCIe cables




Figure 4. One 58/88 PCIe storage enclosure connected to a single 05E/6C system by using two FC EJ03 PCIe2 GX++ adapters and two PCIe cables




Figure 5. Two 58/88 PCIe storage enclosures connected to a single 05E/6C system by using two FC EJ03 PCIe2 GX++ adapters and four PCIe cables




Figure 6. One 58/88 PCIe storage enclosure connected to two 02E/4C or 05E/6C systems by using two FC EJ03 PCIe2 GX++ adapters and two PCIe cables




Figure 7. Two 58/88 PCIe storage enclosures connected to two 02E/4C or 05E/6C systems by using two FC EJ03 PCIe2 GX++ adapters and four PCIe cables




Figure 8. Four 58/88 PCIe storage enclosures connected to two 05E/6C systems by using four FC EJ03 PCIe2 GX++ adapters and eight PCIe cables




Figure 9. One ED/R1 PCIe storage enclosure connected to a single 02E/4D or 05E/6D system by using one FC EJ03 PCIe2 GX++ adapter and two PCIe cables




Figure 10. One ED/R1 PCIe storage enclosure connected to a single 05E/6D system by using two FC EJ03 PCIe2 GX++ adapters and two PCIe cables




Figure 11. Two ED/R1 PCIe storage enclosures connected to a single 05E/6D system by using two FC EJ03 PCIe2 GX++ adapters and four PCIe cables




Figure 12. One ED/R1 PCIe storage enclosure connected to two 02E/4D or 05E/6D systems by using two FC EJ03 PCIe2 GX++ adapters and two PCIe cables




Figure 13. Two ED/R1 PCIe storage enclosures connected to two 02E/4D or 05E/6D systems by using two FC EJ03 PCIe2 GX++ adapters and four PCIe cables




Figure 14. Four ED/R1 PCIe storage enclosures connected to two 05E/6D systems by using four FC EJ03 PCIe2 GX++ adapters and eight PCIe cables




Figure 15. One 02E/4D or 05E/6D with two 58/87 disk drive enclosures connected to a single ED/R1 PCIe storage enclosure by using four SAS EX cables




Figure 16. One 58/88 PCIe storage enclosure connected to an 31E/1C or 31E/2C system by using two FC EJ0H PCIe2 GX++ adapters and two PCIe cables




Figure 17. One 58/88 PCIe storage enclosure connected to two 31E/1C or 31E/2C systems by using two FC E10H PCIe2 GX++ adapters and two PCIe cables




Figure 18. Two 58/88 PCIe storage enclosures connected to two 31E/2C systems by using four FC EJ0H PCIe2 GX++ adapters and four PCIe cables




Figure 19. One ED/R1 PCIe storage enclosure connected to an 31E/1D or 31E/2D system by using two FC EJ0H PCIe2 GX++ adapters and two PCIe cables




Figure 20. One ED/R1 PCIe storage enclosure connected to two 31E/1D or 31E/2D systems by using two FC EJ0H PCIe2 GX++ adapters and two PCIe cables




Figure 21. Two ED/R1 PCIe storage enclosures connected to two 31E/2D systems by using four FC EJ0H PCIe2 GX++ adapters and four PCIe cables




Figure 22. One 31E/2D with two 58/87 disk drive enclosures connected to a single ED/R1 PCIe storage enclosure by using four SAS EX cables




Figure 23. One ED/R1 PCIe storage enclosure connected to an 46L/2T system by using two FC EJ0H PCIe2 GX++ adapters and two PCIe cables




Figure 24. One ED/R1 PCIe storage enclosure connected to two 46L/2T systems by using two FC EJ0H PCIe2 GX++ adapters and two PCIe cables




Figure 25. Two ED/R1 PCIe storage enclosures connected to two 46L/2T systems by using four FC EJ0H PCIe2 GX++ adapters and four PCIe cables




Figure 26. One 46L/2T with two 58/87 disk drive enclosures connected to a single ED/R1 PCIe storage enclosure by using four SAS EX cables




Figure 27. One ED/R1 PCIe storage enclosure connected to a single 08E/8D or 09R/MD system by using one FC 1914 PCIe2 GX++ adapter and two PCIe cables




Figure 28. One ED/R1 PCIe storage enclosure connected to a single 08E/8D or 09R/MD system by using two FC 1914 PCIe2 GX++ adapters and two PCIe cables




Figure 29. one 08E/8D or 09R/MD with two 58/87 disk drive enclosures connected to a single ED/R1 PCIe storage enclosure by using four SAS EX cables




Figure 30. One ED/R1 PCIe storage enclosure connected to a single 17M/MD or 79M/HD system by using one FC 1914 PCIe2 GX++ adapter and two PCIe cables




Figure 31. One ED/R1 PCIe storage enclosure connected to a single 17M/MD or 79M/HD system by using two FC 1914 PCIe2 GX++ adapters and two PCIe cables




Figure 32. Two ED/R1 PCIe storage enclosures connected to a single 17M/MD or 79M/HD system by using two FC 1914 PCIe2 GX++ adapters and four PCIe cables




Figure 33. One ED/R1 PCIe storage enclosure connected to two 17M/MD or 79M/HD systems by using two FC 1914 PCIe2 GX++ adapters and two PCIe cables




Figure 34. Two ED/R1 PCIe storage enclosures connected to two 17M/MD or 79M/HD systems by using two FC 1914 PCIe2 GX++ adapters and four PCIe cables




Figure 35. Four ED/R1 PCIe storage enclosures connected to two 17M/MD or 79M/HD systems by using four FC 1914 PCIe2 GX++ adapters and eight PCIe cables




Figure 36. One 17M/MD or 79M/HD with one 58/87 disk drive enclosure connected to a single ED/R1 PCIe storage enclosure by using two SAS EX cables




Figure 37. One 17M/MD or 79M/HD with four 58/87 disk drive enclosures connected to two ED/R1 PCIe storage enclosures by using eight SAS EX cables

Overview of problem determination

The error log analysis is performed on errors presented by the components in the 58/88 or ED/R1 PCIe storage enclosure, and the analysis recommends actions that need to be performed to correct the errors. Sometimes it refers you to an isolation procedure to further determine what actions can be taken to resolve the problem.

The isolation procedures might refer you to service documentation for an external expansion drawer. The information in this section can be used in those situations.

LED use for the 58/88 or ED/R1 PCIe storage enclosure

The components inside the 58/88 or ED/R1 PCIe storage enclosure can be identified by their physical location code. In addition to the location code, most components have an identify light-emitting diode (LED) that can be activated.

For an overview of using location codes, see 58/88 or ED/R1 PCIe storage enclosure.

For details about the 58/88 or ED/R1 locations, see 58/88 or ED/R1 storage enclosure locations.

The identify indicator LEDs can be accessed from the following locations:

- Hardware Management Console (HMC): Click **Operations** > **LED Status** > **Identify LED**
- AIX diagnostics: Type `diag` > Task Selection > Identify and Attention Indicators
- Linux: Type `/usr/sbin/usysident -s identify -l<location code>`
- Advanced System Management Interface: Click **System Configuration** > **Service Indicators or Indicators by Location Code**

RAID controller location code

The RAID controllers are embedded on the enclosure RAID module (ERM) card and connect to the system by using a PCIe cable. All I/O controllers or adapters attached by a PCIe bus on Power Systems servers inherit the location code of the I/O slot to which they connect.

Generally, the location code of an I/O slot is based on the enclosure in which the nearest upstream PCI bridge resides. This is normally a PCI slot, but for a RAID controller in an ERM, it is where the PCIe cable is connected on the GX adapter in the system unit. Therefore, the logical PCIe slot location code for the RAID controller is associated with the PCIe cable connector location on the GX adapter in the system. This logical location code (L1 in the following example) indicates that the associated RAID controller resource connects to the connector.

The logical PCIe slot location of the RAID controller in an ERM is shown in the following form:

Utttt.mmm.ssssss-Pw-Cx-Ty-L1 (-T1), where:

- *Utttt.mmm.ssssss* is the type, model, and serial number of the system central electronics complex (CEC) enclosure in which the GX adapter resides
- *Pw* is the planar in the system CEC enclosure that the GX adapter plugs into
- *Cx* is the slot on the planar that the GX adapter plugs into
- *Ty* is the PCIe connector on the GX adapter
- *L1* is the logical RAID controller indicator
- *T1* might be appended after *L1* in some cases, but can be ignored

The slot location code previously described is used to call out failures that are isolated to the RAID controller or PCIe hardware in the PCIe storage enclosure. The physical location code of the ERM card is used to call out failures that are isolated to other components on the ERM card. The components can include the serial-attached SCSI (SAS) expander or the SCSI enclosure services (SES) device.

Determining the ERM location from the RAID controller location

You will need to use the RAID controller logical location code to determine the enclosure RAID module (ERM) physical location.



8. Type option 8 to select the associated logical resources for the RAID controller resource that has the logical location code you are working with to find the logical resource name of the virtual I/O processor (IOP) resource. Press Enter.
9. Record the logical resource name of the virtual IOP resource.
10. Return to the HSM main menu and select option 2 to show the logical hardware resources and press Enter.
11. Select option 1 to show the system bus resources and press Enter.
12. Locate the logical resource name of the virtual IOP resource from step 9. Type option 9 to show the resources that are associated with this virtual IOP. Press Enter.
13. Select option F11 to display the serial and part numbers.
14. Locate the device services resource that has the same serial number and part number as the virtual IOP resource. Type option 8 to display the associated packaging resources for the selected device services. Press Enter.
15. Type option 5 to display the details of the device services resource. Press Enter.
16. Use the information on the Packaging Hardware Resource Detail display to determine the ERM physical location that corresponds to the RAID controller.

These isolation procedures might require reseating or replacing the ERM, midplane assembly, or device. Pay careful attention to the 58/88 or ED/R1 SAS resource location information when identifying the possible causes from the isolation procedure that sent you here. Also note that the isolation procedure might specify either that the RAID controller or disk drive are not likely the cause and therefore another possible component must be tried.





Figure 38. Component locations
