DANGER

Observe the following precautions when working on or around your IT rack system:

- Heavy equipment—personal injury or equipment damage might result if mishandled.
- Always lower the leveling pads on the rack cabinet.
- Always install stabilizer brackets on the rack cabinet.
- To avoid hazardous conditions due to uneven mechanical loading, always install the heaviest devices in the bottom of the rack cabinet. Always install servers and optional devices starting from the bottom of the rack cabinet.
- Rack-mounted devices are not to be used as shelves or work spaces. Do not place objects on top of rack-mounted devices.



- Each rack cabinet might have more than one power cord. Be sure to disconnect all power cords in the rack cabinet when directed to disconnect power during servicing.
- Connect all devices installed in a rack cabinet to power devices installed in the same rack cabinet. Do not plug a power cord from a device installed in one rack cabinet into a power device installed in a different rack cabinet.
- An electrical outlet that is not correctly wired could place hazardous voltage on the metal parts of the system or the devices that attach to the system. It is the responsibility of the customer to ensure that the outlet is correctly wired and grounded to prevent an electrical shock.

Removing components from the upper positions in the rack cabinet improves rack stability during relocation. Follow these general guidelines whenever you relocate a populated rack cabinet within a room or building:

- Reduce the weight of the rack cabinet by removing equipment starting at the top of the rack cabinet. When possible, restore the rack cabinet to the configuration of the rack cabinet as you received it. If this configuration is not known, you must observe the following precautions:
 - Remove all devices in the 32U position and above.
 - Ensure that the heaviest devices are installed in the bottom of the rack cabinet.
 - Ensure that there are no empty U-levels between devices installed in the rack cabinet below the 32U level.
- If the rack cabinet you are relocating is part of a suite of rack cabinets, detach the rack cabinet from the suite.
- Inspect the route that you plan to take to eliminate potential hazards.
- Verify that the route that you choose can support the weight of the loaded rack cabinet. Refer to the documentation that comes with your rack cabinet for the weight of a loaded rack cabinet.
- Verify that all door openings are at least 760 x 230 mm (30 x 80 in.).
- Ensure that all devices, shelves, drawers, doors, and cables are secure.
- Ensure that the four leveling pads are raised to their highest position.
- Ensure that there is no stabilizer bracket installed on the rack cabinet during movement.
- Do not use a ramp inclined at more than 10 degrees.
- When the rack cabinet is in the new location, complete the following steps:
 - Lower the four leveling pads.
 - Install stabilizer brackets on the rack cabinet.
 - If you removed any devices from the rack cabinet, repopulate the rack cabinet from the lowest position to the highest position.
- If a long-distance relocation is required, restore the rack cabinet to the configuration of the rack cabinet as you received it. Pack the rack cabinet in the original packaging material, or equivalent. Also lower the leveling pads to raise the casters off of the pallet and bolt the rack cabinet to the pallet.

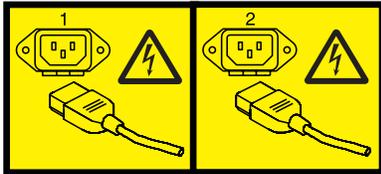

Power and cabling information for NEBS (Network Equipment-Building System) GR-1089-CORE

The following comments apply to the servers that have been designated as conforming to NEBS (Network Equipment-Building System) GR-1089-CORE:

The equipment is suitable for installation in the following:

- Network telecommunications facilities
- Locations where the NEC (National Electrical Code) applies

The intrabuilding ports of this equipment are suitable for connection to intrabuilding or unexposed wiring or cabling only. The intrabuilding ports of this equipment *must not* be metallically connected to the interfaces that connect to the OSP (outside plant) or its wiring. These interfaces are designed for use as intrabuilding interfaces only (Type 2 or Type 4 ports as described in GR-1089-CORE) and require isolation from the exposed OSP cabling. The addition of primary protectors is not sufficient protection to connect these interfaces metallically to OSP wiring.

Note: All Ethernet cables must be shielded and grounded at both ends.

Installing the 58/87 disk drive enclosure

Use this overview as a guide to the tasks required for installing the 58/87 disk drive enclosure (EXP24S SFF Gen2-bay Drawer) into a rack and cabling it to a server.

Procedure

You can use the following table to read about and complete the high-level tasks for installing the 58/87 disk drive enclosure.

Installing the 58/87 disk drive enclosure: Details

The detailed installation procedure includes information from online references that are specified in the overview. You can use the expanded instructions in this procedure to install your disk drive enclosure into a rack and to cable it to a server.

Before you begin

- This information is provided in printed form as a list of basic tasks for installing the 58/87 disk drive enclosure. For the most current version, use the online information: Installing the 5887 disk drive enclosure.
- This procedure supports the following installation scenarios:
 - Your 58/87 disk drive enclosure was delivered already mounted in a rack, and you need to complete the installation.
 - Your 58/87 disk drive enclosure was delivered separately from a rack, and you need to mount the enclosure in an existing rack and complete the installation.

Note: If the rack is not yet installed, you must first complete the procedure for Installing the rack.

- Before installing the disk drive enclosure into a rack, read the Rack safety notices.

About this task

To install the 58/87 disk drive enclosure, complete the following tasks:

1. Choose the type of installation you are performing:
 - To complete the installation of a 58/87 disk drive enclosure that was delivered already mounted in a rack, go to step 2.
 - To complete the installation of a 58/87 disk drive enclosure that was delivered separately from a rack, go to step 3 on page 13.
2. Remove the bracing bracket attached at the rear of the disk drive enclosure as follows:
 - a. Follow these steps to clear the shipping bracket installation area of cables and cords:
 - 1) Find the slotted opening in the small front bracket (**A**) below the left enclosure services manager (ESM) and loosen the power supply cord (**B**) that is visible in the opening. Carefully pull the power supply cord up through the small front bracket opening. When you have removed the connector end of the power cord through the opening (**C**), hang the loose length of cable to one side so that it does not interfere with your workspace in the shipping bracket installation area. Using the same technique, remove and hang the right power supply cord. Do not disconnect or detach the power supply line cords from their attachments to the rack or to other cables.




Figure 1. Removing the power supply line cords from their shipping position

- 2) Leave the serial-attached SCSI (SAS) cables (D) connected to the ESM.

Note: In a basic installation of the 58/87 disk drive enclosure, you are not required to remove the SAS cables. However, if other installation factors require you to remove the SAS cables from the ESM, label the cables before you disconnect them to ensure that you can reconnect them correctly at the end of this procedure.

- b. Loosen the two thumbscrews (A) on the small front brackets below the ESM units. Remove the brackets by lifting them up and away from the ESM units.




Figure 2. Removing the small front brackets

c. Follow these steps to dock and secure the ESM units:

- 1) Moving one ESM at a time, slide the unit approximately 75 mm (3 in.) toward the chassis.




Figure 3. Sliding the ESM units toward the chassis

- 2) For one ESM at a time, place your forefingers under the release levers and pinch the orange lever tips. Release the levers and swing them into their fully open position.





Figure 4. Opening the ESM release levers


- 3) Moving one ESM at a time, slide the unit into the chassis until it stops.

- 4) For one ESM at a time, place your thumbs on the tips of the orange ESM levers and swing the levers into their fully closed and latched position.



- d. Using a screwdriver, remove the screw that attaches the large bracket to the left flange of the rack frame. Remove the screw that attaches the bracket to right flange.

Note: Keep the screws that you removed for their reinstallation in step 2f on page 9.

- e. Slide the large bracket toward the rear of the rack. Lift the bracket with two hands to remove it from the side rails.

Tip: Save all of the brackets that you have removed for any future reinstallation and for shipping of the 58/87 disk drive enclosure that might be required.




Figure 8. Removing the large bracket

- f. Reinstall the screws that you removed in step 2d on page 8 by inserting them into the same holes in the rack frame and side rails from which you removed them. Tighten the screws with a screwdriver.
- g. Follow these steps to dock and secure the power supplies:
 - 1) Moving one power supply at a time, slide the unit approximately 75 mm (3 in.) away from the chassis.





Figure 9. Sliding the power supplies toward the chassis


- 2) For one power supply at a time, rest your right thumb on the orange release latch beside the unit handle and your fingertips on the handle. In one motion, squeeze the release latch to the right and swing the handle down into its fully open position.

- 3) Moving one power supply at a time, slide the unit into the chassis until it stops.

- 4) Moving one power supply at a time, swing the unit handle up and into its fully closed position on the release latch.




Figure 12. Closing the power supply release handle

- h. Follow these steps to complete the reconnection of cables and cords:
 - 1) Take the power supply line cords that you moved to one side in step 2a1 on page 3 and reconnect them to the left power supply and the right power supply.




Figure 13. Connecting the power supply line cords

- 2) Route the power cords through the power cord retention brackets (**D**) for strain relief, as shown in the following figure.





Figure 14. Routing the power cords through the cord retention brackets

- 3) If your installation requirements included the removal of the SAS cables from the ESMs in step 2a2 on page 4, review the labeling that you performed and reinstall the cables.
Go to step 8 on page 21.
3. Unpack the disk drive enclosure as follows:
 - a. Refer to the kitting list provided with the rack installation kit, and complete a parts inventory.
 - b. Locate the rack-mounting hardware kit and the system rail assemblies that were included with your disk drive enclosure.
The rails are front-to-back and left-to-right side dependent.
4. Determine where to install the disk drive enclosure into the rack as follows:
 - a. Determine where in the rack to place the disk drive enclosure in relation to other system hardware. As you plan, keep the following steps in mind:
 - 1) Organize larger and heavier units into the lower part of the rack.
 - 2) Plan to install units into the lower part of the rack first.
 - 3) Record the EIA locations in your plan.

Note: The disk drive enclosure is two Electronic Industries Alliance (EIA) units high. An EIA unit is 44.50 mm (1.75 in.) in height. The rack contains three mounting holes for each EIA unit of height. This enclosure, therefore, is 89 mm (3.5 in.) high and covers 6 mounting holes in the rack.

- b. If necessary, remove the filler panels to allow access to the inside of the rack enclosure where you plan to place the disk drive enclosure.

- c. If necessary, remove the front and rear rack doors.
- d. Mark the rack location where you will install the disk drive enclosure by completing the following steps:
 - 1) Face the front of the rack and work from the left side. Make a note of the lowest EIA unit to be used for the disk drive enclosure. Use tape, a marker, or a pencil to mark the top mounting hole **(A)** of the lowest EIA unit. Count up two holes and place another mark beside that mounting hole **(B)**. Mark the rack so that these marks can also be seen from the rear of the rack.




Figure 16. Marking the installation locations

- 2) Repeat the last step to place two marks on the corresponding mounting holes on the front-right side of the rack.
 - 3) Go to the rear of the rack. On the left side, find the EIA unit that corresponds to the lowest EIA unit marked on the front of the rack.
 - 4) Mark the top mounting hole (C) of this EIA unit. Count up two holes and place another mark beside that mounting hole (D).
 - 5) Repeat the last step to place two marks on the corresponding mounting holes on the rear-right side of the rack.
5. Install the rail assembly into the rack as follows:

Important: To complete this procedure, use two people to attach the rail assembly to the rack. Position one person in front of the rack and one person at the rear of the rack.

CAUTION:

Installing the rails in the rack is a complex procedure. To install the rails correctly, you must perform each task in the following order. Failure to do so might cause rail failure and potential danger to yourself and the system unit.

- a. Select a rail and remove any parts that were taped to it for shipping. Install the spring to the rail by hooking one end to the spring bracket (A) and the other end around the circular standoff (B).

Notes:

- If your rack has the square mounting holes, remove the rail pins from the rail. Install the larger rail pins that are provided with the rack installation kit.
- The rail installation can be completed by one person. However, the installation is easier if one person is positioned at the front of the rack and one person is positioned at the rear of the rack.




Figure 17. Installing the spring to the rail

- b. Open the hinge bracket on each end. Identify the side of the rack where the rail must be mounted by holding the rail inside of the open space of the rack as follows:
- The rail points from front to rear.
 - The support ledge (A) is at the bottom and points toward the center of the open space.
 - The enclosure stop (B) points toward the rear of the rack.




Figure 18. Opening the rail hinge bracket

- c. Locate the two marks made previously on the Electronic Industries Alliances (EIA) strips. Align the rail bracket inside the rack cabinet beside the marks, and seat the rail bracket pins in the mounting holes. The bottom of the rail support ledge appears slightly higher than the U mark on

the rack flange.




Figure 19. Mounting the rail on the rack

- d. At the front of the rail, close the front hinge bracket to secure the rail to the rack cabinet flange.




Figure 20. Securing the rail to the rack

- e. While holding the rail bracket in place, carefully expand the rail until the other end reaches the opposite rack flange. Seat the pins of the opposite rail bracket in the marked mounting holes.
 - f. At the rear of the rail, close the rear hinge bracket to secure the rail to the rack cabinet flange. Install one M5 screw in the open hole in the bracket between the two alignment pins (C).
 - g. Repeat step 5c on page 16 through step 5f for the other rail.
6. Install the disk drive enclosure onto the rails as follows:
- a. Remove the left side bezel (A) and right bezel (B) to expose the mounting brackets. Pinch the release to rotate the bezel up and off of the chassis flange.





Figure 21. Removing the side bezels

- b. Using two people, lift the disk drive enclosure and position it over the front of the rails.


Attention: Two people are required to safely lift the disk drive enclosure. Using fewer than two people to lift the disk drive enclosure can result in injury.




Figure 24. Routing the power cords through the cord retention brackets




Figure 25. Attaching the side bezels




Figure 26. Installing a disk unit in the disk drive enclosure




Figure 27. Mode sticker locations at the rear of the 58/87 disk drive enclosure




Figure 28. Mode 1 connection of one 58/87 disk drive enclosure by using a YI cable to a system with support for a single SAS drawer




Figure 29. Mode 1 connection of one 58/87 disk drive enclosure by using a YO cable to a single SAS adapter




Figure 30. Mode 1 connection of two 58/87 disk drive enclosures by using YO cables to a single SAS adapter




Figure 31. Mode 1 connection of one 58/87 disk drive enclosure by using YO cables to a SAS adapter pair




Figure 32. Mode 1 connection of two 58/87 disk drive enclosures by using YO cables to a SAS adapter pair




Figure 33. Mode 1 connection of one 58/87 disk drive enclosure by using EX cables to a PCIe storage enclosure




Figure 34. Mode 1 connection of two 58/87 disk drive enclosures by using EX cables to a PCIe storage enclosure




Figure 35. Mode 2 connection of one 58/87 disk drive enclosure by using YO cables to two independent SAS adapters




Figure 36. Mode 2 connection of one 58/87 disk drive enclosure by using X cables to two SAS adapter pairs




Figure 37. Mode 4 connection of one 58/87 disk drive enclosure by using X cables to four independent SAS adapters




Figure 38. Labels for SAS adapter cables showing P1 and P2 identifiers




Figure 39. Model 02E/4B connector locations on a rack-mounted model




Figure 40. Model 02E/4B connector locations on a stand-alone model




Figure 41. Model 02E/4C connections for expansion units, disk drive enclosures, and PCIe storage enclosures




Figure 42. Model 02E/4D connections for expansion units, disk drive enclosures, and PCIe storage enclosures




Figure 43. Model 05F/6B connector locations on a rack-mounted model




Figure 44. Model 05F/6B connector locations on a stand-alone model




Figure 45. Model 05E/6C connections for expansion units, disk drive enclosures, and PCIe storage enclosures




Figure 46. Model 05E/6D connections for expansion units, disk drive enclosures, and PCIe storage enclosures




Figure 47. Model 31E/1C connections for disk drive enclosures and PCIe storage enclosures




Figure 48. Model 31E/1D connections for disk drive enclosures and PCIe storage enclosures




Figure 49. Model 31E/2B connector locations on a rack-mounted model




Figure 50. Model 31E/2C connections for expansion units and disk drive enclosures




Figure 51. Model 31E/2C connections for PCIe storage enclosures




Figure 52. Model 31E/2D connections for expansion units and disk drive enclosures




Figure 53. Model 31E/2D connections for PCIe storage enclosures




Figure 54. Model 33E/8B connector locations on a rack-mounted model




Figure 55. Model 46L/1S connector locations




Figure 56. Model 46L/2S connector locations




Figure 57. Model 08E/8D or 09R/MD connector locations




Figure 58. Model 17M/MB or 79M/HB connector locations




Figure 59. Model 17M/MC or 79M/HC connector locations




Figure 60. Model 17M/MD or 79M/HD connector locations




Figure 61. Model 58/87 connector locations
