## Executive summary

NVIDIA reported information about NVIDIA GPU Display Driver for Windows and Linux contains a vulnerability which could allow a privileged attacker to escalate permissions. A successful exploit of this vulnerability might lead to code execution, denial of service, escalation of privileges, information disclosure, and data tampering. NVIDIA published table with lists the NVIDIA software products affected, Linux driver versions affected, and the updated version available from nvidia.com that includes this security update.
